Regulations for Kyushu University Program of Leading Graduate Schools

Kyushu University Regulation No. 34 of 2012

Effective as of: December 1, 2012

(Purpose)

Article 1 – These regulations prescribe the necessary matters regarding the Program of Leading Graduate Schools (hereafter “the Leading Program”) pursuant to Paragraph 2 of Article 17, Sec. 6 of the General Regulations of Graduate Schools of Kyushu University (Kyushu University Regulation No. 3 for 2004).

(Leading Program)

Article 2 – The Leading Program aims to provide education that develops global leaders who possess the ability to command a high-level perspective of issues and to be creative, and who span the fields of industry, academia, and government.

2 – The Leading Program shall be defined as a credited program consisting of master’s studies through doctoral studies.

Article 3 – The title of the Leading Program and the departments participating in the implementation of the Leading Program (hereafter “Participating Departments”) are as described in the following table.

(The Program Director)

Article 4 – The program director shall be installed in the Leading Program, who shall be appointed from candidates selected by the dean from among the Kyushu University faculty.

2 – The program director shall unify the implementation of the Leading Program.

(Committee)

Article 5 – There shall be within the Leading Program a committee (hereafter “the Committee”) for the execution of planning and operations for the Leading Program.

(Selection)

Article 6 – Upon the approval of the Committee, the program director shall establish the selection, preparation and methods regarding student completion of the Leading Program.

2 – The Committee shall select students for participating in the Leading Program based on the preparation and methods prescribed above.

(Education Process)

Article 7 – Graduate schools of the Participating Departments shall establish, upon the approval of the Committee, the requirements for Leading Program completion, such as course items, registration methods, and conditions for certification in the Leading Program.

2 – The faculty meetings of graduate schools which students selected as registrants in the Leading Program

(hereafter “Program Students”) shall certify completion for those students based on the results of a preceding deliberation conducted by the Committee.

- 3 – The dean shall confer degrees as established in the Degree Regulations of Kyushu University (Kyushu University Regulation No. 86 for 2004), based on the report of completion certification as described in the preceding item.

(Financial Allowance)

Article 8 – It will be possible to grant to Program Students funds (hereafter “Financial Allowance”) intended for their research and study activities.

- 2 – The necessary matters for the Financial Allowance shall be established elsewhere.

(Miscellaneous Provisions)

Article 9 – In addition to the provisions established in these regulations, the program director or the heads of the relevant departments shall establish elsewhere those matters necessary for the implementation of the Leading Program.

Supplementary Provision(s)

These regulations shall be effective as of December 1, 2012.
